## 15. CITY MANAGER INFORMATION BRIEF

City Manager Rawlings provided a report on the following items: The City applied for and was awarded a \$75,000 CalTrans grant to help study how to improve traffic flow in the City and needed maintenance. Negotiations have been concluded with a cell provider (federal law now allows cell providers to put a cell tower whether the City wants it or not). The cell site will be at the Artesia Town Center, and should generate \$360,000 up front for the City in non-tax, non-grant, money. In ongoing efforts to improve staff quality and bring a variety of skill-sets to the City, the City has brought on Edith Guerra as the Parks and Recreation Assistant Manager.
