SPECIAL PROCEDURES

As a result of the Coronavirus (COVID-19) pandemic, states of emergency have been declared in the County of Los Angeles and the state of California. The President of the

United States has declared a federal emergency. At the direction of the Governor, starting March 19, 2020, the entire state is subject to stay-at home orders. These measures are imposed to reduce the risk of spreading COVID-19. To comply with these emergency measures, the Public Safety Commission meeting will be open and public but conducted via teleconference only. This way the public, the staff, and the Council will not be physically in the same place. The City is endeavoring to employ technology that will allow the public to view the meeting live and participate.
